classes to the archives at Memorial Library to learn about SUNY Cortland history. For my lesson on inquiry methods, I go to the library for a lecture on using primary sources.

I rely heavily on technology in my courses. For every class meeting I run a Webex session so that students who are absent can hear the lecture and participate in any activities. Thanks to the technology-equipped classrooms we have at Cortland this is not complicated at all and given the recent increase in students absences due to health conditions this has prevented students from falling behind in their work. I also use Blackboard to give frequent, regular assessments. This allows me to create assessments that will be low penalty but also randomized for each student, helping both I and the students to track comprehension of the course materials.

In the future I plan to incorporate more of the on-campus resources here at Cortland into my course. I think that this is a good way to model to pre-service teachers how they can use resources in their towns and schools in their own classrooms in the future.
